Player Waiver, Release of Liability and Indemnification Agreement

I, the undersigned player, acknowledge, agree, and understand that:

1. Voluntary and of my own free will, I elect to participate as a member of the golf ball team and league/tournament indicated above.
2. I understand that there are certain risks and hazards involved in participating in golf that may result in injury or death to me or other players, including, but not limited to those hazards associated with weather conditions, playing conditions, equipment and other participants.
3. I understand that swinging a golf club is dangerous to me and to other players and may result in serious injury or death.
4. I understand that the very nature of the game of golf is hazardous and risky, including, but not limited to, the acts of pitching, throwing a golf club or ball can cause serious injury or death to me and to other players.

Further, I, the undersigned player, agree that in consideration for the right to play as a member of the team designated above and in consideration for permission to play on the fields arranged for by the team or leagues:

1. I voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designated, (b) while serving in a non-playing capacity as a team member during practice or play by other teams or by other players on my team, and (c) while on or upon the premises of any and all of the fields arranged for by my team or league for practice or play.
2. I release, discharge and agree not to sue the team and tournament designated above, the field owner or other entity designated above, The City of Foster City, officers, agents, servants, associations, employees, or any person or entity connected with the team, tournament, field for any claim, damages, cost or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to negligence, breach of contract or wrongful conduct of the parties hereby released.

I acknowledge that I have read and that I understand each and every one of the above provisions in this waiver, release of liability and indemnification agreement and agree to abide by them.
