

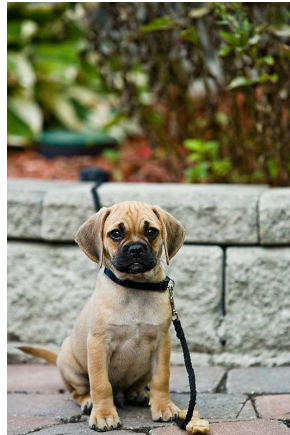

## *Dog Parks Rules and Ordinances*

The Department of Parks and Recreation asks that you be courteous and respectful of other park users and that you comply with all rules and ordinances.

**Foster City Dog Park** is located in Boat Park at the corner of Foster City Blvd. and Bounty Dr. It has separate, fenced-in areas for big and small dogs, and consists of synthetic grass decomposed granite.

**Hours of Operation:**

**6am—10pm Daily**



**Other Parks for Dogs:**

Dogs may be off-leash (but under control) between the hours of 5am-8am in designated areas of the following parks:

**Boothbay Park**

Corner of Edgewater Blvd. and Boothbay Ave.

**Catamaran Park**

5am-8am

Corner of Shell Blvd. and Catamaran Street

**Edgewater Park**

Corner of Edgewater Blvd. and Regulus St.

**Farragut Park**

Corner of Beach Park Blvd. and Farragut Blvd.

**Sea Cloud Park**

5am-8am M-Sat

5am-9am Sun

Corner of Pitcairn Dr. and Sea Cloud Park Dr. The designated area is in the back of the park.

**Foster City Dog Laws / Ordinances**

**No more than 3 dogs per owner/agent allowed in the park at one time.**

(6.04.070 I.1)

**Leash** Except in designated off-leash areas, the City requires that dogs be restrained by a leash and be held by a person reasonably competent to restrain and control the dog. (6.04.070A)

**License** A license tag must be attached to a collar which the animal wears at all times. (6.04.040E)

**Dangerous Animals** Owners must prevent their pets from biting or physically harassing any person engaged in a lawful act and from interfering with the lawful use of public or private property. (6.04.060A) Owners must prevent their pets from causing substantial injury to another domestic animal while such animal is lawfully upon public or private property. (6.04.060B)

**Trespassing** Owners are prohibited from allowing their pets to trespass upon private property. (6.04.070A)

**Public Nuisance** Owners must exercise proper care and control of an animal to prevent it from becoming a public nuisance. Violations include excessive, continuous or untimely barking, chasing vehicles, habitually attacking other domestic animals, trespassing on school grounds, or trespassing on private property and causing damage (6.04.070G)

**Excreta** Owners are required to immediately remove their pets' excreta from any property other than that of the owner. (6.04.070H)

**Dog Park Rules**

Please read and abide by the following rules so that everyone can enjoy this facility.

- Every dog must be wearing a sturdy collar or harness with license tags in order to enter the park.
- **You must clean up after your dog.**
- **Owner/agent should watch their dogs at ALL times.** Owner/agent is responsible for the dog's behavior and any damage caused by the dog.
- **Leash dogs while entering and exiting the dog park.**
- **Spaying and neutering** are recommended.
- Do not leave your dog unattended.
- No puppies less than four months. (immature immune system)
- Aggressive dogs and female dogs in heat should not be brought into the park.
- Supervise small children.
- No food or alcohol allowed inside the Dog Park.
- Dog owners must provide their own dog drinking bowls for health reasons.
- **All dog bites must be reported.** (Call 650-286-3300)
