It's simple, it's free and it's available now!!

You can never have enough time or money. Now you can save a little of both when you pay your water and sewer bill automatically. **Auto-Pay Service** allows you to pay your bill automatically by having the City of Foster City deduct the total amount of your water and sewer bill from a checking or savings account at a bank, credit union, or savings and loan.

- You'll continue to receive a bi-monthly bill showing the date your payment will be made
- You'll have 21 days from the date of your bill statement to review the bill and resolve any discrepancies before the payment is withdrawn
- You can discontinue **Auto-Pay Service** by notifying us in writing at **least 5 working days before the next payment due date**

Just think – no more checks, stamps or trips to City Hall. Your bills will be paid for you on time, every time. You won't have to worry about missing a payment if you're out of town on business or on vacation.

Enrollment is easy. Simply complete the authorization slip below and send it back with a voided check (deposit slips will not be accepted). **Auto-Pay Service** will begin on next billing. You may mail the required information to the **City of Foster City, 610 Foster City Blvd., Foster City, CA 94404** or fax it to **(650) 286-2561** or email to **utility@fostercity.org**.

Continue to pay your water and sewer bill in the usual manner until the following message appears on your bill: "*Your bank account will be drafted for: \$\_\_\_\_\_*". Proof of payment will appear on your next bank statement and on your next bi-monthly water and sewer bill.
