# LEVEE SUBCOMMITTEE SPECIAL MEETING MINUTES Friday, November 6, 2020 2:00 PM

The special meeting of the Levee Subcommittee was called to order on Friday, November 6, 2020 at 2:04 p.m. via Zoom.

#### V. Approval of September 22, 2020 Meeting Minutes (Annotated Agenda)

Informal notes were taken for the September 22, 2020 meeting, which took place prior to the formalization of the Levee Subcommittee. No action necessary.

Norm Dorais reviewed the Monthly Construction Manager's Report. The construction value remains the same and there is no change in final completion dates. Change Order #2 is related to the deletion of the requirement to coat the sheet piles and is

circulating. The project is nearing the start of production. Mobilization has occurred at larger sites, and the first sheet piles have been delivered to Sea Cloud Park.

There were no requests for the Subcommittee to approve today.

b. Communication Project Tracker – through 10/23/20

Norm Dorais reviewed the communication project tracker items through October 23, 2020. Press Releases have gone out regarding detours and the groundbreaking ceremony. Renderings of what the levee will look like in different areas have been posted to the City's website. The renderings will also be included with the Recology billing that will be mailed out the second week of December.

The Subcommittee Members requested that the communication tracker include meetings with HOAs, sports leagues, and any other stakeholder groups. The Subcommittee Members also requested that HOA board members or managers are copied on communications to residents inquiring on behalf of HOAs.

Norm Dorais provided a bond update. The City may draw funds only once per month. The City completed an initial draw of funds in September; however, an additional draw of funds was not necessary for the month of October. It is likely that another draw will be needed in November. Norm is coordinating with Financial Services Director Edmund Suen to determine the amount of the draws.

The Levee Bond Oversight Committee met on October 28. Norm Dorais reviewed the Minutes from that meeting.

#### VIII. New Business

a. Levee Update Report for 11/16/20 City Council Meeting

The Subcommittee Members determined that they will lead the discussion and presentation to the City Council at its Regular Meeting on November 16. Staff will provide the Subcommittee Members with talking points and a visual aid prior to the City Council meeting.

Council/Subcommittee Member Jon Froomin discussed several less-widely known but positive elements of the project including: 1) there will be more benches and picnic tables as amenities, 2) the rapid flashing beacons will aid community members in safely getting to the levee pathway, and 3) the new pathway will be wider and striped with 4 lanes – 2 for pedestrians and 2 for bicyclists. Council/Subcommittee Member Froomin requested that the striping plan be shared with the public.

There were no additional communication or comments from committee members.

#### X. Good of the Order

Norm Dorais suggested holding the Levee Subcommittee meetings the first or second week of each month since the monthly management report would be available and could then be presented to Council at its second meeting of the month. The next meeting of the Levee Subcommittee will be scheduled for the first week of December.

The Subcommittee Members discussed potential impacts to the City's parks. If any damage is caused to the parks because of this project, the contractor is responsible to restore the parks to the same or better shape. The Public Works Department is coordinating with the Parks and Recreation Department where feasible, and members of the Parks and Recreation Department are included at the weekly meetings with the contractor.

The Subcommittee Members also discussed potential impact to the City's roads. There will be no damage assigned to the normal truck routes as those are meant for the trucks. For non-truck routes, the City's paving schedule will be coordinated so that the streets are restored using funds available to the City and specifically meant for road maintenance rather than finance the maintenance through the 30-year bond.

There were no other items to come before the Levee Subcommittee, and the meeting was adjourned at 2:40 p.m.
