10 Amendment? This tax is wrong. Don't be tempted. Just say "No".

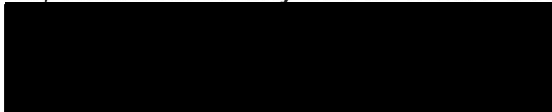
16 In fact, this measure should not even be allowed on the ballot. The ballot statement is

16 argumentative and biased statements, but governments still try them anyway.

15 Department, or do anything in particular with the money. The actual law says the money is
15 unrestricted and they can spend it as they please. But the ballot statement might mislead
13 you to think some money is reserved for important uses. It is not.
