- **1.02 Project Description:** The work consists of striping removal, crack sealing, pavement grinding, localized asphalt concrete repair, asphalt overlays, slurry seal, pavement reconstruction, curb and gutter repair, curb ramp installment/replacement, installation of traffic striping and markings, installation of traffic signage, grade adjustments, bituminous layer repair, paver replacement, and utility adjustments.
- **1.03** Completion of Work: All work shall be completed within **115 calendar days** for the date when the Contract Time commences to run.

- 1.07 Non-Mandatory Pre-Bid Meeting: Owner will conduct a Non-Mandatory Pre-Bid Meeting at the at 2:00PM on Tuesday, April 30, 2024 at Street Rehabilitation and Park Pathway Restoration, 610 Foster City Blvd, 2<sup>nd</sup> Floor Public Works Conference Room, Foster City, CA. The Non-Mandatory Pre-Bid Meeting will last approximately 0.5 hours.
- **1.08** Bid Preparation Cost: Bidders are solely responsible for the cost of preparing their Bids.
- **1.09 Reservation of Rights:** Owner specifically reserves the right, in its sole discretion, to reject any or all Bids, to re-bid, or to waive inconsequential defects in bidding not involving time, price or quality of the work. Owner may reject any and all Bids and waive any minor irregularities in the Bids.

## **ARTICLE 2 LEGAL REQUIREMENTS**

**2.01** Required Contractor's License(s): A California class A contractor's license is required to bid this contract. Joint ventures must secure a joint venture license prior to award of this Contract. Specialty work may require a specialty contractor's license C held by Bidder or a listed

subcontractor. A City of Foster City Business License is required throughout the duration of the contract.

# 2.02 Required Contractor and Subcontractor Registration

- A. Owner shall accept Bids only from Bidders that (along with all Subcontractors listed in Document 00 4314, Subcontractor List) are currently registered and qualified to perform public work pursuant to Labor Code Section 1725.5.
- B. Subject to Labor Code Sections 1771.1(c) and (d), any Bid not complying with paragraph 202A above, shall be returned and not considered; provided that if Bidder is a joint venture (Business & Professions Code Section 7029.1) or if federal funds are involved in the Contract (Labor Code Section 1771.1(a)), Owner may accept a non-complying Bid provided that Bidder and all listed Subcontractors are registered at the time of Contract award.

# 2.03 Bid Alternates:

- A. Bid alternates are identified as follows:
  - 1. Alternate 1: E. 3<sup>rd</sup> Ave, East of Foster City Blvd to Bayside Towers
  - 2. Alternate 2: E. 3<sup>rd</sup> Ave, West of Foster City Blvd to City Limit
- B. The determination of lowest bid shall be based upon:
  - 1. Base contract bid plus bids for Alternates 1 and 2 listed immediately above. The City reserves the right not to award either Alternate 1 or Alternate 2.
- 2.04 Substitutions: Bidders must base their bids on products and systems specified in Contract Documents or listed by name in Addenda. Except as provided below, Owner will consider substitution requests only for "or approved equal items." Bidders wanting to use "or approved equal items" may submit request on form to be obtained from Owner no later than 7 days after issuance of Notice of Award
- **2.05 Substitution of Securities:** Owner will permit the successful bidder to substitute securities for any retention monies withheld to ensure performance of the contract, as set forth in Document 00 6290 Escrow Agreement For Security Deposits in Lieu of Retention and incorporated herein in full by this reference, in accordance with Public Contract Code Section 22300.
- 2.06 Prevailing Wage Laws: The successful Bidder must comply with all prevailing wage laws applicable to the Project, and related requirements contained in the Contract Documents. Copies of the general prevailing rates of per diem wages for each craft, classification, or type of worker needed to execute the Contract, as determined by Director of the State of California Department of Industrial Relations, are on file at the Owner's Public Works Department, may be obtained from the California Department of Industrial Relations website and are deemed included in the Bidding Documents. Upon request, Owner will make available copies to any interested party. Also, the successful Bidder shall post the applicable prevailing wage rates at the Site.
- **2.07 Prevailing Wage Monitoring:** This Project is subject to prevailing wage compliance monitoring and enforcement by the Department of Industrial Relations.
