

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the City Council of the City of Foster City will hold a PUBLIC HEARING on Monday, December 15, 2025, at 6:30 p.m. to hear and consider public input on the following:

- 1. INTRODUCTION OF AN ORDINANCE AMENDING TITLE 17, "ZONING" OF THE FOSTER CITY MUNICIPAL CODE BY ADDING A NEW CHAPTER 17.15 "SINGLE-FAMILY AND TWO-FAMILY OBJECTIVE DESIGN AND DEVELOPMENT STANDARDS" AND FINDING THE AMENDMENTS WITHIN THE SCOPE OF THE ENVIRONMENTAL IMPACT REPORT (EIR) PREPARED FOR THE FOSTER CITY HOUSING AND SAFETY ELEMENT UPDATE (SCH NUMBER 2022010509).

INTRODUCTION OF AN ORDINANCE AMENDING TITLE 17, "ZONING" OF THE FOSTER CITY MUNICIPAL CODE BY RESCINDING CHAPTERS 17.50 "ACCESSORY BUILDINGS AND USES" AND 17.54 "YARDS"; AND AMENDING CHAPTERS 17.04 "DEFINITIONS"; 17.12 "R-1 SINGLE-FAMILY RESIDENCE DISTRICT": 17.14 "R-2 TWO-FAMILY RESIDENCE DISTRICT"; "ARCHITECTURAL CONTROL AND SUPERVISION": 17.96 "MULTIFAMILY AND RESIDENTIAL MIXED-USE OBJECTIVE DESIGN AND DEVELOPMENT STANDARDS"; AND FINDING THE AMENDMENTS WITHIN THE SCOPE OF THE ENVIRONMENTAL IMPACT REPORT (EIR) PREPARED FOR THE FOSTER CITY HOUSING AND SAFETY ELEMENT UPDATE (SCH NUMBER 2022010509).

A RESOLUTION OF THE CITY COUNCIL RESCINDING ARCHITECTURAL AND SOLAR GUIDELINES; AND VARIOUS POLICIES PERTAINING TO REVIEW OF SINGLE-FAMILY AND TWO-FAMILY HOMES, INCLUDING POLICY NO. 2001-113 AWNINGS; POLICY NO. 2-2000 REROOFING POLICY; POLICY NO. 03-001 COPPER GUTTERS, DOWNSPOUTS AND FLASHING POLICY; POLICY NO. 18-10 WINDOW REPLACEMENT POLICY; POLICY NO. 01-02 BAY/BOW/GARDEN AND GREENHOUSE WINDOW POLICY; POLICY NO. 1-2000 SOLAR IMPACTS; AND POLICY NO. 2-2000 EXTERIOR COLOR CHANGE POLICY; AND FINDING THE REQUEST WITHIN THE SCOPE OF THE ENVIRONMENTAL IMPACT REPORT (EIR) PREPARED FOR THE FOSTER CITY HOUSING AND SAFETY ELEMENT UPDATE (SCH NUMBER 2022010509).

Prior to taking action at the November 20, 2025 meeting, the Planning Commission approved staff's recommendation to revise references to C-U zoning district in the proposed section 17.58.020(B)(3) to C-O, C-A and to preserve Policy No. 1-2000 (Evaluating Room Additions) and Policy No. 03-002 (Security Gates). With those revisions, the Foster City Planning Commission voted 5-0 approving recommending the foregoing ordinances and resolution to the City Council.
