## ORDINANCE NO. 696

AN ORDINANCE OF THE CITY OF FOSTER CITY AMENDING SECTION 1.01.010, "ADOPTION-SECONDARY CODES ADOPTED," OF CHAPTER 1.01, "CODE ADOPTION," WITHIN TITLE 1 OF THE FOSTER CITY MUNICIPAL CODE ADOPTING BY REFERENCE CERTAIN PARTS, INCLUDING RELATED APPENDICES, AS IDENTIFIED IN THE 2025 CALIFORNIA BUILDING CODE, 2025 RESIDENTIAL CODE, 2025 CALIFORNIA MECHANICAL CODE, 2025 CALIFORNIA PLUMBING CODE, 2025 CALIFORNIA ELECTRICAL CODE, 2025 CALIFORNIA FIRE CODE, 2025 CALIFORNIA ENERGY CODE, 2025 CALIFORNIA GREEN BUILDING STANDARDS CODE, THE 2025 CALIFORNIA EXISTING BUILDING CODE AND THE 2025 WILDLAND-URBAN INTERFACE CODE WITHIN TITLE 24 OF THE CALIFORNIA CODE OF REGULATIONS; AND FINDING THE AMENDMENTS EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) PURSUANT TO CEQA GUIDELINES SECTION 15061(B)(3)

## CITY OF FOSTER CITY

THE CITY COUNCIL OF THE CITY OF FOSTER CITY DOES HEREBY ORDAIN, as follows:

Section 1. The City Council finds that with the adoption of the various codes and amendments found in Title 15, namely the California Building Code, California Residential Code, California Plumbing Code, California Mechanical Code, California Electrical Code, California Fire Code, California Energy Code, California Existing Building Code, the California Green Building Standards Code and the California Wildland-Urban Interface Code, is necessary to adopt an ordinance to update Title 1, Chapter 1, Section 1.01.010 reflect current the California to the edition of Building Standards

**Section 2. Amendment.** Section 1.01.010, "Adoption-Secondary codes adopted" of Chapter 1.01 within Title 1, "General Provisions" is hereby amended by repealing and replacing in its entirety to read as follows:

## "1.01.010 Adoption -- Secondary codes adopted.

Pursuant to the provisions of Sections 50022.1 through 50022.10 of the Government Code of the state of California, there is adopted the "Foster City Code," including the following secondary codes incorporated by reference in whole or in part, including related appendices, as identified in Title 24 of the California Code of Regulations, Parts 2, (Vols. 1 & 2), 2.5, 3. 5, 10 and 11: 4. 6. 7.

- A. Code entitled "California Building Code", 2025 Edition, published by the International Code Council, with California Amendments;
- B. Code entitled "California Residential Code", 2025 Edition, published by the International Code Council, with California Amendments;

- C. Code entitled "California Mechanical Code", 2025 Edition, published by the International Association of Plumbing and Mechanical Officials, with California Amendments:
- D. Code entitled "California Plumbing Code", 2025 Edition, published by the International Association of Plumbing and Mechanical Officials, with California Amendments:
- E. Code entitled "California Electrical Code", 2025 Edition, published by the National Fire Protection Association, with California Amendments;
- F. Code entitled "California Fire Code", 2025 Edition, published by the International Code Council, with California Amendments;
- G. Code entitled "California Energy Code", 2025 Edition, published by the International Code Council, with California Amendments;
- H. Code entitled "California Green Building Standards Code", 2025 Edition, published by the International Code Council;
- I. Code entitled "California Existing Building Code", 2025 Edition, published by the International Code Council;
- J. Code entitled "California Wildland-Urban Interface Code, 2025 Edition., published by the International Code Council.

Save and except those portions of the preceding secondary codes as are deleted, modified or amended by provisions of the Foster City Code.

From and after the effective date of the ordinances codified in this chapter, the Foster City Code shall constitute the penal and regulatory ordinances of the city of Foster City."

**Section 3.** CEQA. The adoption of this ordinance is exempt from the California Environmental Quality Act ("CEQA"), in that the adoption of State codes and the local amendments herein described do not have the potential for causing a significant effect on the environment, pursuant to Sections 15061(b) (3) and 15378(b) (5) of the CEQA Guidelines (Title 14, Chapter 3 of the California Code of Regulations). The adoption of this ordinance is also exempt from CEQA pursuant to Section 15308 of the CEQA Guidelines as actions by a regulatory agency to assure the maintenance, restoration, enhancement, or protection of the environment

**Section 4.** Repeal of Conflicting Ordinances. All former Ordinances or parts thereof conflicting or inconsistent with the provisions of this Ordinance or of the Code hereby adopted are thereby repealed.

**Section 5.** <u>Severability</u>. If any section, subsection, sentence, clause, or phrase of the Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted the Ordinance and each section, subsection, clause, or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared invalid.

**Section 6.** Taking Effect. This Ordinance shall take effect on January 1, 2026.

**Section 7.** Posting. Within 15 days after the passage of this Ordinance, the City Clerk shall have it posted in three public places designated by resolution of the City Council.
