ORDINANCE NO. <u>585</u>

AN ORDINANCE OF THE CITY OF FOSTER CITY AMENDING SECTION 1.01.010, SECONDARY CODES ADOPTION, OF CHAPTER 1.01, CODE ADOPTION, OF TITLE 1, GENERAL PROVISIONS, OF THE FOSTER CITY MUNICIPAL CODE

CITY OF FOSTER CITY

THE CITY COUNCIL OF THE CITY OF FOSTER CITY DOES HEREBY ORDAIN, as follows:

Section 1. The City Council finds that with the adoption of the various codes and amendments in Title 15, namely the California Building Code, California Residential Code, California Plumbing Code, California Mechanical Code, California Electrical Code, California Fire Code, California Energy Code, and the California Green Building Standards Code, it is necessary to adopt an ordinance to update Title 1, Chapter 1, Section 1.01.010 to reflect the Editions of the various codes adopted.

Section 2. Title 1, Chapter 1.01, Section 1.01.010, A, B, C, D, E, F, G, and H are amended to read as follows:

- C. Code entitled "California Mechanical Code", 2013 Edition, published by the International Association of Plumbing and Mechanical Officials, with California Amendments;
- D. Code entitled "California Plumbing Code", 2013 Edition, published by the International Association of Plumbing and Mechanical Officials, with California Amendments;
- E. Code entitled "California Electrical Code", 2013 Edition, published by the National Fire Protection Association, with California Amendments;
- F. Code entitled "California Fire Code", 2013 Edition, published by the International Code Council, with California Amendments;
- G. Code entitled "California Energy Code", 2013 Edition, published by the International Code Council, with California Amendments;
- H. Code entitled "California Green Building Standards Code".

Section 3. Repeal of Conflicting Ordinances. All former Ordinances or parts thereof conflicting or inconsistent with the provisions of this Ordinance or of the Code hereby adopted are thereby repealed.

Section 4. <u>Severability</u>. If any section, subsection, sentence, clause, or phrase or the Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it should have adopted the Ordinance and each section, subsection, clause, or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared invalid.

Section 5. Taking Effect. This Ordinance shall take effect and be in force 30 days from and after its adoption.

Section 6. Posting. Within 15 days after the passage of this Ordinance, the City Council shall have it posted in three public places designated by resolution of the City Council.
