**REQUEST FOR QUALIFICATIONS:**

1. Evaluation and Analysis – Paragraph 2 (RFQ pg. 7)

**Delete** paragraph 2, as written below, in its entirety,


“In addition to the minimum requirements listed above, the City will allocate 5 additional points to the scoresheet below for applicants who are signatory to a trade union agreement and an additional 2 points for a place of business that is identified in the Pre-Qualification Questionnaire Submittal as physically located within the geographic boundary limits of the City of Foster City, for a total of 7 points if both conditions are met.”

and **Replace** with the following:

“In addition to the minimum requirements listed above, the City will allocate a total of 7 points for the utilization of local labor, which shall be calculated as follows:

- 5 points to the scoresheet below for applicants who are signatory to a trade union agreement.
- 2 points to the scoresheet below for applicants who have a place of business that is identified in the Pre-Qualification Questionnaire Submittal as physically located within the geographic boundary limits of the City of Foster City.

A total of 7 points will be awarded if both of the foregoing conditions are met.”
