FOSTER CITY PARKS FOR DOGS

BARK PARK is located in Boat Park at the corner of Foster City Boulevard and Bounty Drive. It has fenced-in areas for big & small dogs, a grassy area, and play apparatus for dogs.



OTHER PARKS FOR DOGS:

Four additional parks are available for off-leash dog exercise on a LIMITED basis. Dogs can only be offleash (but under control) between the hours of 5:00 AM to 8:00 AM in designated areas of the following parks:

EDGEWATER

(on the corner of Edgewater Boulevard and Regulus)

BOOTHBAY

(on the corner of Edgewater Boulevard and Boothbay)

CATAMARAN

(on the corner of Shell and Catamaran)

SEA CLOUD

(on the corner of Pitcairn and Sea Cloud - in the back of the park)

Dogs are not allowed on synthetic turf at any of the above parks at any time.

BARK PARK RULES

PLEASE READ AND ABIDE BY THE FOLLOWING RULES SO THAT EVERYONE CAN ENJOY THIS FACILITY

- Dog Park is open daily from dawn until 10pm
- Dogs must be leashed and gates securely closed, when entering or leaving the dog park
- Keep you dog(s) away from gates when other dogs are entering
- Maximum of three (3) dogs per adult allowed at one
- Owner must carry a leash for their dogs at all times.
- Dogs must be supervised by their owners at all times
- Small dog park is for dogs 26 pounds or less
- Large dog park is for dogs 26 pounds and over
- · Cleaning up after your pet, both inside and outside of the dog park is required
- Dogs must display current rabies tags
- Any aggressive dog must be leashed and removed from the dog park
- Owners must stop their dogs from digging and fill any holes caused by their dogs
- No dogs are allowed on the furniture

STRICTLY PROHIBITED

- Human and dog food/treats
- Glass containers
- Dogs in heat or sick dogs
 - Aggressive dogs
- Puppies under six (6) months
- Smoking, chewing of tobacco, vaping and alcohol
- Motorized or human propelled devices (except wheelchairs)

Owners are legally responsible and liable for the action of their dogs and injuries or damage caused by their

FOSTER CITY DOG LAWS

6.16.010 Public protection from dogs.

Every owner or possessor of a dog shall at all times prevent such dog from biting or physically harassing any person or another domestic animal.

6.16.030 Restraint of dogs.

Dogs must be restrained by a competent person and competent leash in order to restrain and control the dog to ensure that the animal will not endanger other persons or animals; and dogs in specified dog runs must be accompanied by a person reasonably competent to restrain and control the dog.

6.20.010 Dog licenses.

An annual license fee shall be paid for every dog over the age of four months owned and harbored in this jurisdiction. The owner of a dog for which a license is required shall affix such license to a suitable collar, which collar shall remain on the dog at all times.

6.16.050 Prohibited Nuisances

A. It is unlawful for any owner or person entrusted with the care of any dog, to fail to exercise proper care or control of such animal so that the animal becomes a public nuisance.

- B. Excessive, continuous or untimely barking, molesting of passersby, chasing vehicles, habitually attacking other domestic animals, trespassing upon schoolgrounds, or trespassing upon private property in such manner as to damage property is a nuisance.
 - C. A female dog in heat running at large is a public nuisance.

6.16.060 Excreta on another's property

Dog owners must clean up after their dogs. Violations shall be punishable by a fine.

6.28.020 Animals permitted.

The following animals may be kept: A. Not more than two dogs and two cats of more than six months of age subject to the licensing requirements of Chapter 6.20; B. The offspring of dogs and cats of the household up to

the age of six months; C. Other household pets which are not kept outside. (Ord. 344 § 1 (part), 1988)
