On 11-09-2025, at 0946 hours, I was dispatched to the front counter of FCPD (1030 E. Hillsdale Blvd.) on a report of a lost expired Republic of Turkey passport and a current Republic of Turkey passport (#U29034388) with a United States of America tourist visa. I was assigned to the Field training Program with Ofc. Nix #40.

Upon arrival, Ofc. Nix and I activated our department issued body-worn cameras and recorded our interactions during this incident. We later uploaded our footage to the Axon Evidence.com Library.

We met with [PO] DOGAN Susuz, who identified himself with his Republic of Turkey Identification Card (#35750248082), and [M] DERYA Caglar Susuz, who identified herself with her CA driver's license (Y7836130). They stated the following:

DOGAN was visiting his sister, DERYA for the last two weeks. On November 8, 2025 while at the airport, he was attempting to return to Turkey and found that his passports were missing.

He last saw his Republic of Turkey passports around November 6, 2025.

Since then, he went to various locations such as the Livermore outlets, restaurants in Burlingame, Bridgepointe Shopping Center (San Mateo), Golden Gate Park (San Francisco), and the City of Sausalito.

They returned to the various locations in an attempt to locate his lost passports, but were unable to locate them.

DOGAN planned to report the lost passport to the Turkey Consulate in Los Angeles to get a replacement passport.

He provided me with a digital photograph of his current passport, and I downloaded it to the secure R: drive at the FCPD (Item #3).

I took digital photographs of DOGAN's Republic of Turkey Identification card and Republic of Turkey Driver's license with my Department issued cellphone, which I later uploaded to the secure R: drive at FCPD (Item #4).

I had dispatch enter his lost passport into the APS.
