Water is a precious resource! Thank you for taking steps to save water and lower your monthly bill.

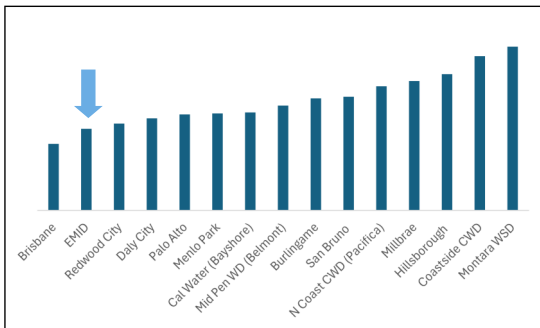
- Switch from lawn to drought-tolerant landscape.

You are hereby notified, pursuant to Government Code Section 53759, there is a 120-day statute of limitations for challenging any new, increased, or extended water fee, rate, or charge. As such, that any judicial action or proceeding to attack, review, set aside, void, validate, or annul the District Board's adoption of the proposed water rates must be commenced within 120 days of the effective date or of the date of the final passage, adoption, or approval of the ordinance or resolution adopting the water rates.

## Public Hearing Notice

The Estero Municipal Improvement District (EMID) will hold a public hearing to establish new water rates for FY 2024-2025 with an increase of 4.5% for fixed water charges and 3.8% for variable water consumption charges for residential Tier 1 rates. As a water customer or owner of record for a property that receives water service, we are informing you that the District Board will hold a public hearing on **June 3, 2024, at 6:30 p.m.** to consider proposed changes to its current rates to take effect on July 1, 2024.

### Why are new water rates being proposed?

A significant driver for the proposed rate increases is to smooth District rate adjustments due to projected increases in the San Francisco Public Utilities Commission (SFPUC) wholesale water rate. The SFPUC, the sole water supplier for the District, projects that its wholesale rate will increase from \$5.21 per hundred cubic feet (ccf) in FY 2023-2024 to \$5.55 per ccf in FY 2024-2025. These increases are included in the projected rates.

Other adjustments were required to provide necessary revenue for the maintenance, operational and capital costs associated with the water distribution enterprise.

### Protest of Proposed Rates

Anyone may appear and be heard on any matter relating to the proposed water rates. Any record owner of a parcel upon which fees are proposed, or any tenant directly responsible for the payment of water service fees (i.e. a customer of record), may submit a written protest to the City Clerk / District Secretary at the return address in this notice. Per state law, only one protest per parcel will be counted. A written protest must include: (1) the address or parcel number of the impacted property; (2) a statement that the protest is submitted in opposition to increases to the water rate; and (3) the name and original signature of the person submitting the protest. Electronic and verbal protests will not be counted. If the District does not receive written protests against the proposed service charges by a majority of the affected parcels by the end of the public hearing, then the District is authorized to approve the proposed rates.

### Proposed Water Rate Changes

The proposed water rates were calculated to ensure that all customers are paying rates that are proportionate to each customer's costs of service. The proposed rate revisions that will be considered by the EMID Board are based on a water rate study ("Study") conducted by Bartle Wells Associates. ### Single-Family Residences

Single-family residences with responsibility for indoor (domestic) and outdoor (irrigation) water uses are placed in a tiered rate structure whereby the cost of water increases based on the amount of water used in a **bi-monthly** billing cycle as follows:

Tier (#ccf)	Current	Proposed FY 2024-2025
Tier 1—0 to 20	\$6.36	\$6.60
Tier 2—Over 20	\$7.01	\$7.33

### Multi-Family Residences (per living unit)

Multi-family residences with responsibility for indoor water uses are placed in a tiered rate structure whereby the cost of water increases based on the amount of water used in a **bi-monthly** billing cycle as follows:

Tier (#ccf)	Current	Proposed FY 2024-2025
Tier 1—0 to 10	\$6.36	\$6.60
Tier 2—Over 10	7.09	7.36

### Irrigation Customers

Irrigation customers with **separate irrigation water meters** are provided an individually-prepared water budget based on the square footage of landscaping being watered. Usage within the water budget allotment will be charged at \$6.60/ccf. Usage over the water budget allotment will be charged \$7.80/ccf for every unit of water over the allotment. Customized reports through the year let customers know how they are doing in water use.

### Why is There No Public Hearing for Wastewater Rates?

The District Board previously held a public hearing to approve a maximum rate increase of 2% for FY 2024-2025 to support debt-financing costs associated with the District's share of expanding the Wastewater Treatment Plant jointly owned with the City of San Mateo. The EMID Board is planning a rate increase of 2% in FY 2024-2025, which does not require an additional public hearing because it does not exceed the approved increase.
